




### ADVISORY TO EDUCATOR

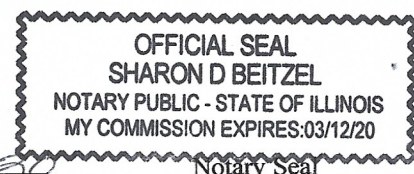



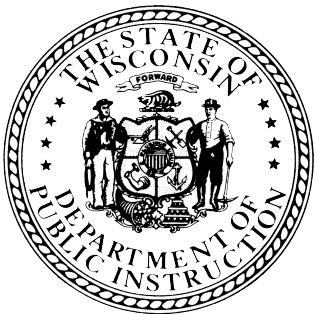
