November Technical Meeting Highlights by Craig Miller




The November Technical Meeting featured Dr. J. Jay Marino, Superintendent of Schools in the Dunlap Community Unit School District 323 in Dunlap, IL. His presentation dealt with the teaching and use of quality tools for the betterment of the educational process.

At first thought one would think "OK, they are showing spreadsheets to the teachers about expenses and student test results." Oh, contraire! Everyone in the Dunlap School District is using quality tools, setting goals, sitting on improvement teams and charting the results...everyone. Custodians, bus drivers, cafeteria staff and the like sit on teams that identify opportunities and then work to improve the district's support services. Teachers and school administrators sit on teams working to better improve modes of learning and student participation. And then there are the students themselves; from kindergarten kids to high school seniors, all are involved in goal setting and charting results. Grade school students are using Pareto diagrams, creating radar and affinity charts. All students contribute to improve their learning process in the classroom. It is no wonder that Dunlap is an award winning school district. Please note that in the background of Dr. Marino's picture there is a modified Plan-Do-Study-Act "wheel" first developed by Walter Shewhart and widely accepted as a model for process improvement. The Tech Meeting program, interlaced with short video segments (some created by the students themselves) was very informative and emphasized the point that quality tools are not relegated solely to the manufacturing and service sectors. When properly applied, in this case to education, quality tools can be used for improvement over a broad spectrum of applications.

Ellis Ott began his career thinking that he would be a pure mathematician. After receiving a bachelor's degree at Southwestern College in Kansas, a master's degree from the University of Kansas, and a doctorate from the University of Illinois, he worked at the University of Arkansas as a mathematics instructor. He was a professor of mathematics at the University of Buffalo from 1934 to 1946. Ott's career reached a turning point in 1946, when he took a job with the National Union Radio Corp. in Newark, NJ. There he was in charge of applying statistical quality control methods to the production of guided missiles. "Once he started in quality control, he knew that would be his field of endeavor," Virginia Ott, his wife, said. When he was offered the chairmanship of the mathematics department at Rutgers University College in 1946, he accepted on the condition that he could also teach and consult in quality control.

"The mathematics department considered that "Ott's Folly," Mrs. Ott said, "but they agreed."

In 1960 Ott received the Shewhart Medal for his outstanding contributions to the quality control field. Further recognition of Ott's efforts came in 1968, when he received ASQ's Grant Award. He was eventually appointed professor of applied and mathematical statistics at Rutgers, and upon his retirement in 1972 was named professor emeritus.

The Heart of Illinois Section 1211 of the American Society for Quality announces their annual scholarships to be awarded to students attending colleges/universities that are in the Heart of Illinois region. Section 1211 is offering the following two scholarships in the amount of \$500 each:

Frank M. Gryna Scholarship

Jan E. Droege Scholarship

The winners of the awards will be selected by the Section 1211 Scholarship Committee with the approval of the Section Leadership Committee based upon the following criteria:

- 1. Must be a full or part time student of at least sophomore level during the year of the award.
- Shall have a high level of academic achievement as evidenced by overall grade point average (3.0 or above on a 4 point scale). A transcript must be submitted with the letter of application.
- Shall demonstrate an interest in a quality based profession as shown by two or more of the following:
 - a. Major in Industrial Engineering, Manufacturing Engineering, Statistics, Business or other course of study as acceptable to the committee.
 - b. Classes taken in Statistics and/or Quality Control.
 - c. Membership in ASQ.
 - d. Work experience in a quality related field.
- Must provide a letter of recommendation from a professor, work supervisor, or other individual familiar with the applicant and his/her studies and experience. (The letter of recommendation cannot be from a fellow student.)
- Must be enrolled in a college or university in the ASQ Section 1211 area, a list of approved institutions is at the bottom of this page.
- 6. The application should be in the form of a letter giving details of educational qualifications and career objectives, accompanied by a current transcript, letter(s) of recommendation and any other supporting documentation to be sent to the Education Committee Chairman at the address below:
